OVERVIEW

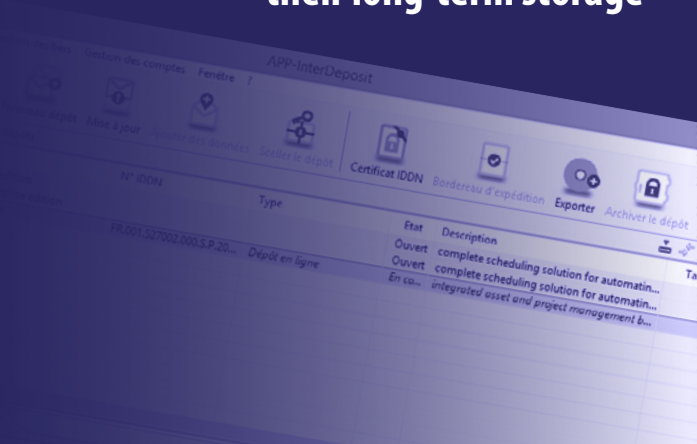
The data you deposit are associated with unequivocal **evidentiary files** archived in real time at your facilities and with APP.

InterDeposit supplies you with an encrypted **digital Logibox** (digital sealed envelope) containing both the elements in your deposit and the digital evidentiary files associated with them.

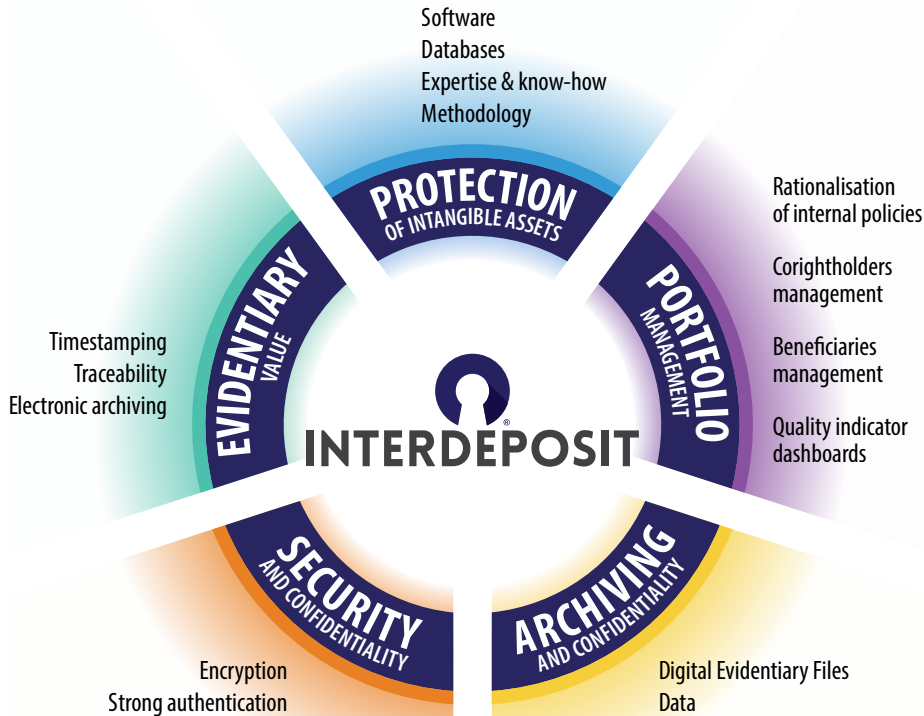
InterDeposit affords you access to **APP's deposits' custodial services**, whereby APP holds a copy of your digital Logibox, stored at your option on a **secure server** or in a **sealed physical envelope** (a physical "Logibox").

To sum up, the InterDeposit solution assures you:

-  **Certainty of the date** through timestamping
-  **A link attesting rights ownership**, thanks to the signature
-  **Digital fingerprinting** to mark each file and the combination of all the constituent files in a deposit
-  **Regular monitoring of your data integrity** (for a digital deposit)
-  **A link to APP** for assignment of an IDDN number to your deposits and to APP custodial services

Enhance

The InterDeposit solution enables you to deploy a comprehensive copyright management policy, among other purposes to provide evidence and thus enhance the value of your intangible assets.

Rationalise

By combining technologies used to provide evidence (timestamping, signature, digital fingerprinting, archival storage) and business-specific functions, InterDeposit helps you rationalise and enhance the effectiveness of your copyright management policy.

Memorise

InterDeposit memorises and maps the changes in your intangible asset base over time.

KEY FEATURES

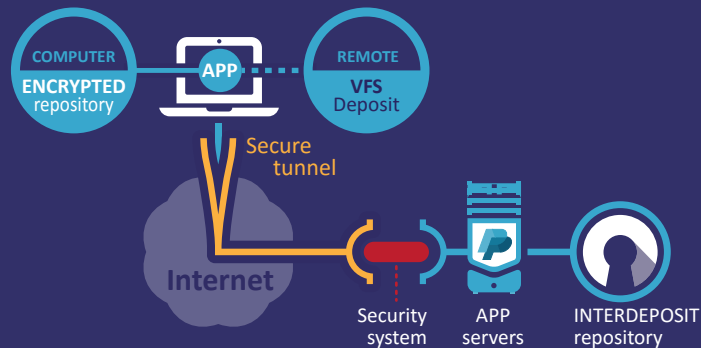
Multiple works portfolio, quality rights management process...

If you have many digital works, effortlessly organise the process of compiling and storing the evidence substantiating your intangible asset base

- \$ A dashboard of indicators makes for worry-free monitoring and control of the changes in your works portfolio. You can **map your digital asset base** whether held by you alone, or as corightholder: intuitive tree-structured mapping of the deposited works and their updates; access to the list of folders and files in each deposit
- \$ Access at any time to the various **deposit certificates**, authenticated by QR code
- \$ Collect your data as they arrive, until they become complete and ready for deposit. The application memorises your actions as and when they are performed. You can interrupt and resume collection of content for deposit at any time
- \$ **Worry-free deposit:** Collect your content for deposit by copying and pasting or dragging and dropping, regardless of their original location (locally, on servers, on external media); simplified on-line deposit form; single-click sealing of the deposit
- \$ **Rapid deposit:** You have possession of your electronic Logibox (sealed electronic envelope) from the moment that you activate the sealing of your deposit in the application. If you wish to transfer your deposit for custody at APP, you should enable the "digital deposit" option. Sending physical media to APP is a thing of the past: your digital Logibox is transmitted directly through a secure tunnel, then archived at APP

If you wish to provide proof of a quality process as part of your copyright management policy

- \$ You can devise and control a **standardised deposit process**: digital evidentiary files compiled and transmitted in real time to APP; as-it-comes monitoring and checking of data deposited; electronic authentication and signature
- \$ **Archiving with evidentiary value** at APP of your digital evidentiary files and your data
- \$ **Security:** encryption of deposits
- \$ **Traceability of deposit status:** from collection to archiving by APP, even in the case of physical-media deposits
- \$ Continuous **interaction** with APP via the application

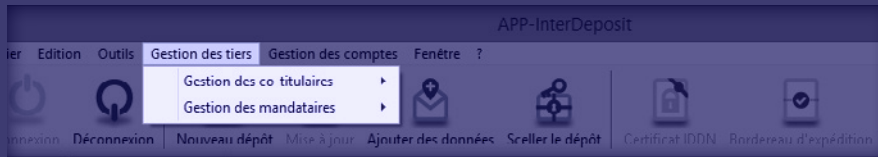


KEY FEATURES

... teamwork, escrow agreements management

In your organisation, generating and validating deposits involves several persons, with content collected from dispersed sources (e.g. decentralised R&D, multiple servers), and discontinuous content collection

- \$ You can manage **multiple users**
- \$ Manage **attorneys** if your legal advisers make deposits on your behalf
- \$ Administrator: rapidly **monitor** actions in progress or those performed by users and attorneys
- \$ Export your **indicator dashboards** to Microsoft Office formats for compiling management reports



If you have initiated an escrow relationship with a client or partner for some of your works or deposits

- \$ Automate release of information to your partners on the deposits of relevance to them
- \$ Use a standardised application to reassure your partners regarding the quality of your deposits

Focus on security

InterDeposit incorporates:

- \$ Strong authentication (login/password + SMS)
- \$ Data management via a proprietary, encrypted SSH client
- \$ As-it-comes data encryption
- \$ For deposits, anonymised containers created and individually encrypted (AES 256)
- \$ Traceability: as-it-comes compilation of an evidentiary repository, application and system logging
- \$ Electronic data archiving that complies with the most stringent standards: electronic archiving certified to NF Z 42-013, and Tier 3+ hosting
- \$ Compliance with the French RGS general security framework and regular external audits under the ISSP

FEATURES IN DETAIL

An uncluttered interface harbours an array of powerful features: simple and efficient shared procedures

Member account

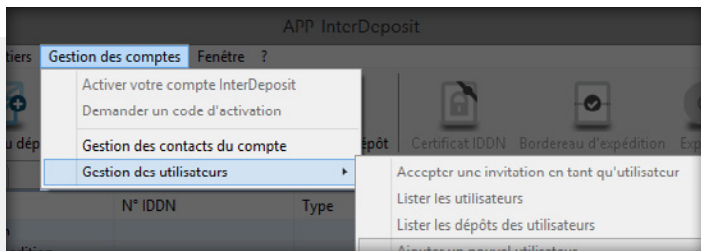
- \$ Create or modify your account
- \$ Create and manage users

Third parties

- \$ Create and manage attorneys
- \$ Create and manage corightholders
- \$ Create and manage escrow beneficiaries

Preparing and performing a deposit

- \$ Create and populate an envelope containing the data to deposit
- \$ Complete the deposit form and seal the deposit



Transmit to APP the deposited data for custody

(postal or on-line deposit options)

- \$ Transmit your deposits to APP on a physical media (DVD, HD, USB keys ...)
- \$ Transmit digital deposits to APP
- \$ Your information reaches you in real time in InterDeposit upon processing of your deposits by APP : IDD number and certificate, archiving date

Monitor your evidentiary record

- \$ Access to your deposit certificates
- \$ Option for allocating per-user deposit quotas
- \$ Management of attorneys depositing on your behalf
- \$ Indicator dashboard and monitoring of deposits in progress or completed
- \$ Exporting of indicators to Office formats

Managing an escrow arrangement

- \$ Declare your beneficiaries and manage the mailing list
- \$ Configure the information to which they have access within your escrow deposits
